## 6. Location is Saddle Peak Equestrian Center 3336 Spain Bridge Road Belgrade, MT

- a. Directions:
  - i. **From the Belgrade exit off I-90**, go North on Jackrabbit Lane .8 mile to the stoplight, turn right (East) on Main Street. Go 2.1 miles East on Main Street, past the main entrance to the airport to Airport Road. Turn left (North) on Airport Road and go 2.6 miles to the junction with Spain Bridge Road. Turn left (North) on Spain Bridge Road which will become a gravel road almost immediately. The Saddle Peak Equestrian Center is the first large arena you will come to, about 1.2 miles on Spain Bridge Road. It is about 10-15 minutes from Belgrade.
  - ii. **From the 19th St. exit on I-90 in Bozeman:** Go North on 19th St. for .3 mile, turn right (North) on Springhill Road for 4.1 miles then turn left (West) on Airport Road. Go 1.5 miles then turn right (North) onto Spain Bridge Road which immediately turns into a gravel road. The Saddle Peak Equestrian Center is the first large arena you will come to, about 1.2 miles on Spain Bridge Road. It is about 15-20 minutes from most motels in Bozeman.

## 7. Awards

- a. Day Money and average awards given each weekend for each class open, nursery, intermediate and novice.
- b. Overall series winners awards for each class open, nursery, intermediate and novice
- c. NOTE: dog and handler team must stay the same thru out events to be eligible for awards.
